Birthday Party Rules and Regulations Agreement

Rules and Regulations:

- No alcohol.
- No glass containers.
- No outside food or drinks. You may purchase food and/or drinks from our merchants.
- Please do not move fountain furniture.
- Please be mindful of shoppers and other fountain guests.
- You are responsible for the safety of the children in your party. Should you have a first aid emergency, please contact Security at **972.637.6303**.
- You are responsible for damaged caused by you or your guest(s).
- No music or boom boxes.
- Must abide by Code of Conduct and Fountain Rules at all times (posted on the Village Green).
- No signs or banners.
- No electrical cords.
- Payment must be received 7 days prior to party or risk cancellation.
- Must check-in at Guest Services (next to the Security Office) upon arrival for your party.
- Maximum of 15 children per party.

If your party is cancelled due to inclement weather, you must call the Uptown Village at Cedar Hill management office within 48 hours after your scheduled party to receive a refund or to be rescheduled. Refunds will be given on the next business day during management office hours (M-F 8am-5pm). Cancellations require a 48 hour notice prior to the scheduled birthday party in order to receive a full refund. Beyond 48 hour notice, no refund will be given.

FOUNTAIN RULES

The fountain is open from 9 a.m. to 10 p.m. daily.

Please observe the following rules so the fountain is enjoyable for all guests:

- Fountain is for children **10 years old or younger - maximum height of 48"**.
- All children must be accompanied & supervised by an adult at least 18 years old in the fountain area at all times.
- Maximum adult-to-children ratio is 1 to 10. Groups over 10 are discouraged and must be approved in advance by Uptown Village Management.
- Use caution when playing in the fountain as the surface is slippery when wet. Rough play and running is not permitted.
- Appropriate swim attire is required to use the fountain. Swim diapers are required for young children. Rubber footwear is encouraged.
- Adults are required to wear shirts and shorts/pants at all times and may only be on the outer ring of the fountain when monitoring a toddler or infant.
- Unauthorized parties and events are not allowed without prior Uptown Village Management approval.
- Diaper changes must be done in designated restroom areas.
- Coolers and food from outside Uptown Village are not permitted on property unless sanctioned by Uptown Village Management.
- Glass is not permitted.
- Toys, water guns, balls, etc., are not allowed in the fountain.
- Bikes, skateboards, rollerblades, etc., are not permitted in or around the fountain.
- Pets or animals of any kind are not allowed in the fountain.

Uptown Village at Cedar Hill Management reserves the right to deny use of the fountain to any person violating any property rules. Thank you for helping us keep the fountain clean and safe for all guests.
